RESOLUTION SAG-1864-2015

VIEW: To award the Contract of the International for Public Bidding process, identified as: LPI No. 01-2015. "TURNKEY PROJECT OF PUMPING STATIONS AND IRRIGATION, INTENDED FOR THE DEVELOPMENT OF AGRICULTURE PROJECT, LOCATED IN JAMASTRAN, VALLEY, OF THE REPUBLIC OF HONDURAS".

WHEREAS: In January 2014, it was signed the Credit Line Agreement for the amount of TWENTY SIX MILLION FIVE HUNDRED THOUSAND DOLLARS (UU\$ 26,500,000.00), between Government of Honduras and Import and Export Bank of India, which main offices are in the Mumbai City, India, known as: "EXIM BANK". This Credit Line Agreement was approved for the National Congress of Honduras, with Decree Number 14-2014, dated March 11, 2014 and it was published in a Newspaper Property of the State of Honduras. This newspaper is intended to publish all laws approved by National Congress and it is known in our nation, as "LA GACETA". The Newspaper where was published the Credit Line Agreement, has a circulation number 33427, dated May 15, 2014. The credit line will be used for the execution of the "TURNKEY PROJECT OF PUMPING STATIONS AND IRRIGATION, INTENDED FOR THE DEVELOPMENT OF AGRICULTURE PROJECT, LOCATED IN JAMASTRAN, VALLEY, OF THE REPUBLIC OF HONDURAS".

WHEREAS: In the Article 1, 3.1. letter c) of the Legislative Decree No. 14-2014, is mentioned that Government of Honduras, should carry out a bidding process just and transparent to select the supplier to execute the Contract. Also, the annex 1 of the Legislative Decree No. 14-2014, letter c), mentioned the tender process it is restricted to companies registered in India and/or incorporated or installed under whatever current law in the Country of India.

WHEREAS: In August 17, 2015, the responsible to lead the Secretary of the Agriculture and Livestock, through a memorandum No. SAG 055-2015, integrates the committee of evaluation of bids received.

WHEREAS: In the Section III related with basis bidding, denominated "TOTAL CALIFICATION OF THE BIDS", only will be considerate those bids whose punctuation be equal or higher to eighty (80%) per cent, the highest bid to join technical, economic and financial evaluations, will be the offer indicated to develop the project before mentioned, and it will be selected to award the Contract.

WHEREAS: In September 23, 2015, the evaluation committee, elaborated the document RECOMMENDATION MINUTE TO ADJUDICATE OFFERS, based in the Articles 51 and 52 of Procurement Law of the State of Honduras; Article 136 paragraph c) of the regulation of the Procurement Law; recommend to the responsible to lead the Secretary of Agriculture and Livestock awards International Public Bidding LPI No. 01-2015. "TURNKEY PROJECT OF PUMPING STATIONS AND IRRIGATION, INTENDED FOR THE DEVELOPMENT OF AGRICULTURE PROJECT, LOCATED IN JAMASTRAN, VALLEY, OF THE REPUBLIC OF HONDURAS" to the company: APOLLO INTERNATIONAL LIMITED, for the amount of TWENTY TWO MILLION FIVE HUNDRED FOURTEEN THOUSAND THREE HUNDRED FORTY DOLLARS OF THE UNITED STATES OF AMERICA (USD 22, 514, 340.00), for presenting the best offer, obtaining 92.61%.
